Subject: A.C. Reynolds High School – Athletic Capital Outlay Request

A.C. Reynolds High School is requesting to use \$7,757.50 from their Athletic Capital Outlay funds. The requested funds will be used to purchase a Fisher 5-Man Bull Sled from Cook's Sporting Goods.

A.C. Reynolds High School Principal, Ms. Doris Sellers approves the use of Athletic Capital Outlay funds for this purchase. The A.C. Reynolds High School Advisory Council also voted to approve using Athletic Capital Outlay funds for this purchase.

Mr. David Ball, District Athletic Specialist, has reviewed the documentation for this request. Per my email communication with Mr. Ball, he supports purchasing Fisher 5-Man Bull Sled from Cook's Sporting Goods.

Pursuant to Buncombe County Board of Education Policies 6430-R (State Purchasing Requirements for Equipment, Materials and Supplies) and 6440 (Local Purchasing Requirements for Equipment, Materials, and Supplies), the Purchasing Department verifies the purchasing requirements for the above referenced purchase have been satisfied. A.C. Reynolds High School received three quotes and is purchasing the Fisher 5-Man Bull Sled using the lowest quoted price.

Dear Board of Education Members,

I would like to request the use of \$7,757.50 of our ACRHS Athletic Capital Outlay money for the purchase of a 5 man lev sled for our football program. The following rationale justifies this purchase:

- *We would like to use our Athletic Capital Outlay for the purchase of a 5 man lev sled for our football program, which serves around 80-90 of our students. The current one we have is also over 20 years old, unsafe, and unusable; as well as out of date for it's purpose. In general, football is a self-sufficient program but the impact of COVID has resulted in our football revenues assisting the school wide athletic program so none of our programs were not negatively impacted during COVID. The cost of this piece of equipment, including tax and delivery is \$7,757.50. This item would allow our players to work on blocking, block destruction, and tackling without using another player, or more body to body contact; resulting in a safer environment on a daily basis for our athletes.*

This item has received three bids and we would like to use the lowest bidder of Cook's – Your Sports Store. The purchase, installation, and set-up of this item will be monitored by our football coaching staff; Mr. McCurry, athletic director and assistant principal; and our Booster organization.

This use of our athletic capital outlay fund has been discussed by our Football coaches, Athletic Booster Club, and administration and, by policy of these funds, have been approved by our Advisory Council via an email vote. The context of Athletic Capital Outlay funds was discussed with the Advisory Council at our September meeting so they fully understand their role in approval and the specific designated use of these funds.
