APPROVAL OF AGENDA

Mr. Elliot made a motion to approve the agenda and Ms. Lewis seconded the motion – the motion was approved unanimously.

SUPERINTENDENT'S COMMENTS

- Dr. Jackson recognized the two hundred and thirteen graduates from eleven high schools that
 crossed the stage this past weekend, having earned their high school diplomas! He noted that
 this was the largest cohort of mid-year graduates in the school system's history.
- Earlier in the week, Dr. Jackson stated that fourteen high school students representing each of BCS' districts joined together with Mr. Hough and Ms. Reed as the Student Advisory Council was relaunched. The group shared their individual and collective thoughts on our school system and how we might continue to improve our service to students.
- Dr. Jackson congratulated the ten Buncombe County Schools teacher who just earned their initial National Board Certified Teacher (NBCT) status and the fifty-one teachers across the system who successfully renewed their NBCT status. He stated that BCS continues to rank eighteenth in the country in the number of NBCTs employed in the school system.

- Dr. Jackson shared that the Buncombe County Schools Foundation has announced the beginning of Scholarship Season! The Foundation provides over \$300,000 in scholarships each year. Information on all scholarships can be found on the Buncombe County Schools Foundation Website.
- The Elementary and Intermediate Schools All-County Chorus will perform on February 28 at 6 p.m. at Brookstone Church in Weaverville. Dr. Jackson invited the Board and Community to attend.
- Dr. Jackson said that the Superintendent's Listening and Learning Adventure is continuing. He
 has now visited all forty-five of our schools and has spent a full school day in eighteen schools.
 "Town hall-style" meetings have been held in four of the six districts and the next meeting will be
 held in the North Buncombe district this coming week. Dr. Jackson said he has enjoyed the
 opportunity to meet parents and community members.

CURRICULUM FEATURE

• "Blending Educational Strategies Together" (B.E.S.T.) – Robert Frisby, Director of Technology and Janet Frazier, Media/Digital Learning Specialist

Ms. Frazier described what "Blended Learning" is and how training has occurred for all staff on multiple digital classroom platforms. Mr. Frisby shared the Technology Services team's "Why". He said their driving goal is to provide the best in services through staff field techs, asset management, low voltage and electrically run equipment, PowerSchool to undergird the schools, blended learning coaches, and a network team that manages cyber security are just some of the daily services that Technology provides to the BCS system. Mr. Frisby recognized the team for the hard work over the last three years and thanked them for always doing their best.

PUBLIC COMMENT

- -Kelly Smith, a parent and speech language pathologist in the North Buncombe district, spoke in support of pre-K programs hosted in our school and voiced concerns over possible changes to the program.
 -Dr. Nyssa Rayne, a parent from the North Buncombe district expressed concerns surrounding Covid and air quality issues in the schools.
- Logan Davis, a student at Roberson High School and member of FCCLA, shared about the FCCLA opportunities that the organization has afforded her and expressed gratitude for being able to participate in FCCLA. She thanked the staff of the CTE department and BCS for the support.
- -Carson Hollifield, a student at North Buncombe High School and the FCCLA State President, spoke of the importance of FCCLA in the schools and how it has impacted her life.
- Jemma Richards, a student at North Buncombe High School and member of FCCLA, shared about her involvement in FCCLA and the leadership skills and creativity she gained by participating in FCCLA at the local and state conference levels.
- -Shanna Peele, a teacher at Woodfin Elementary and the BCAE President for BCS, thanked Dr. Jackson for his time spent in the schools and asked the Board to support higher pay for teachers and a living wage for all staff by requesting more funding from the local county commissioners.
