- III. Teambuilding Exercise
- IV. Whole Board Training
  - Training was conducted by Ms. Julie Rhame with the Georgia School Board
    Association. The training was three hours in duration and covered board
    ethics, roles and responsibilities, protocols, and norms.
- V. State of the System
  - Dr. Brooksher gave an update on demographics, student enrollment, and school tax information.
  - Ms. Melanie James presented the board with updates from the Finance Department.

- Our 2018 Financial Efficiency Star rating is 4.0 out of 5.
- o For every \$1 budgeted, we spend .89 on personnel.
- o 72.5% of the budget is spent on Instructional Support.
- Dr. Trey Robertson presented the board with updates from the Operations and Student Services Department.
  - Our Technology Department has added internet connection to increase bandwidth capabilities at our South Bryan schools.
  - Security cameras are currently being updated at BCHS, BCMS, and RHMS.
  - o Approximately 34% of our students receive free and reduced meals.
  - o Our social workers have served 711 students and their families.
  - o We have over 1,500 participants in middle and high school athletics.
  - We have over 1,000 participants in middle and high school fine arts programs.
- Ms. Mary Beth Brothers presented the board with updates from the Human Resources Department.
  - We hosted our first Educator Interview Day and out of 100 interviewed, 20 were hired for the 2018-19 school year. We are preparing for the next Educator Interview Day scheduled on January 31st.
  - o We continue to conduct salary reviews on a cycle for all positions.
  - o We have 16 vendors online as part of our Employee Perks Program.
- Dr. Brooksher presented the board with updates from the Teaching and Learning Department.

- For the 2018-19 school year through January, we have enrolled 100 new ESS students.
- Our high school graduation rate is at 88.12% for 2018 which is an increase from 2017.
- In April 2015, Bryan County Schools began operating as a Strategic Waiver System.

## VI. Strategic Plan

- The BOE adopted a strategic plan in April 2016.
- Our plan is built on five strategic goal areas that include Fiscal
   Accountability, Organizational and Operational Effectiveness, Parent and
   Community Partnerships, High Performing Workforce, and Student
   Achievement and Success.

### VII. Board Discussion

- The board requested that we research team booster programs on their fundraising guidelines.
- The board requested information about expansion of our CTAE programs and a career academy. Dr. Brooksher shared that this topic will be presented at tomorrow's called work session under Capital Projects.
