Duties and Responsibilities of the Principal

1.0 Purpose:

The principal of each school has the responsibility for the supervision, management, Instructional Leadership, and control of their school within the guidelines established by the Wirt County Board of Education. The major areas of such responsibility shall be the general supervision of all the school activities involving pupils, teachers, and other school personnel.

Under the supervision of the Superintendent, the principal shall further assume administrative and instructional supervisory responsibility for the planning, management, operation, and evaluation of the total educational program of the school or schools to which he/she is assigned.

2.0 Definitions:

- 1. Clear and Focused Mission: The schools's purpose and approach to support learning for all
- 2. Instructional Leadership: Ensuring the effectiveness of instruction leads to student achievement
- 3. High Expectations for Success: Ensuring the effectiveness of instruction leads to student achievement
- 4. Positive and Safe Environment: Orderly, purposeful, and accommodating of all students' needs
- 5. Equitable Opportunities to Learn and Effective Instruction: Sufficient time for meaningful learning is provided to all students
- 6. Frequent Monitoring of Student Progress: A variety of data used as the basis for adjusting the instructional approach
- 7. Family and Community Partnerships: Purposeful relationships exist between families, community, and the school

3.0 Responsibility:

In addition to established laws, policies, rules and regulations, job descriptions for administrators shall include the following responsibilities:

Providing purpose and direction for schools/county

Demonstrating cognitive skills to gather, analyze, and synthesize information to reach goals

Managing consensus, collaboration, and group behaviors

Enhancing quality of total school/county organization

Organizing and delegating to accomplish goals are communicated effectively

Instructional Leadership using systems and processes - data driven decisions

4.0 Procedures:
