Educational Programs and Services

1.0 Purpose:

The goal of Wirt County Schools is to provide an educational process which will enable students to succeed in the classroom and in the workplace, to lead rewarding and productive lives, and to participate responsibly in society.

- 1.1 The Wirt County Schools policy for delivering educational programs and services parallels WV State Board Policy 2510 which provides the regulations for all education programs to improve the quality of teaching and learning in the public schools, as well as to ensure that equal education opportunities exist for all students.
- 1.2 The educational program offered by Wirt County Schools is defined as all of the educational activities that take place during the school day and the school year, and is structured and based on four programmatic levels: early childhood education, middle childhood education, adolescent education, and adult education. Within these programmatic levels, the education program includes the programs of study that make up the curriculum, instructional practices, and student support services described in State Board Policy 2510.
- 1.3 Wirt County Schools assures that it will provide a high quality delivery of its educational program, as well as a thorough and efficient educational system that gives equal access to curriculum and related services for all students. Wirt County Schools is committed to providing the necessary resources to ensure that students achieve basic skills in reading, writing, mathematics, and computer applications--skills which will provide the foundation for later intellectual challenges in all programs of study.

2.0 Procedures:

- 2.1 Wirt County Schools will make available the programs of study identified in Charts 1-5 in keeping with State Board Policy 2510. The courses listed in Section 4.2 through 6.0 must be taken by all students as noted in each section. The courses needed for graduation (Chart 5) require mastery of the WV College and Career Readiness Standards. (See also Wirt County Policy I-06 Promotion, Retention & Graduation Requirements; I-08 Alternative Education Programs for Students, I-09 Simulated Work Place/Work Based Learning Policy, I-10 Dual and College Credit Policy.
- 2.2 Any elective offering must be based on WV Board of Education approved College and Career Readiness Standards or on written goals and objectives that are approved by the Wirt County Board of Education.

3.0 SEVERABILITY:

Any conflict between this policy and state statute shall be resolved by following the statute. If any portion of this policy or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect other provisions or applications of this policy. Changes or updates to legislative items requiring compliance will be included as needed by decision of the Superintendent.

REVIEW SCHEDULE:

This policy shall be reviewed in accordance with the policy review schedule published by the Superintendent.
