The Wirt County Board of Education met in their regular session on Tuesday, November 12, 2013 in the Wirt County High School cafeteria. Present were James Rader, President, Mark Lowe, Chuck Mills, and Edward Powell, members, MaryJane Pope Albin, Secretary, Karen Cummings, Treasurer, absent – Carl Brainard, Vice President.

Mr. Rader called the meeting to order at 6:03 p.m. The Pledge of Allegiance was led by Emily Young.

Brenda Metz & Daniel Metz addressed the meeting under Delegations/Callers.

On a motion by Mr. Lowe, seconded by Mr. Powell, the Board approved the minutes of the previous meeting held on October 22, 2013.
