The Wirt County Board of Education met in their regular session on Tuesday, October 8, 2013 in the Wirt County High School cafeteria. Mr. Rader called the meeting to order at 6:02 p.m. The Pledge of Allegiance was led by Shania Tanner.

Presentations/Updates: Student Input - Zach Ojanpera-Lynch submitted information to the Board regarding a recycling project he would like to conduct within the schools. He will follow-up with the principals.

Superintendent Pope-Albin discussed that Mon Power has rescheduled the Power Outage for October 9, 2013 to November 11, 2013, which is a holiday for the school system.
