MINUTES OF THE WIRT COUNTY BOARD OF EDUCATION
September 10, 2013

The Wirt County Board of Education met in their regular session on Tuesday, September 10, 2013 in the Wirt County High School cafeteria. Present were James Rader, President, Carl Brainard, Vice President, Mark Lowe, Chuck Mills, Edward Powell, members, MaryJane Pope Albin, Superintendent, and Karen Cummings, Treasurer.

Mr. Rader called the meeting to order at 6:00 p.m., on a motion by Mr. Mills, seconded by Mr. Lowe, the minutes of the previous meeting held on August 27, 2013 were approved.

On a motion by Mr. Powell, seconded by Mr. Brainard the Board authorized payment of invoices totaling \$75,277.03, approved a FFA funding request for \$1,600 and approved school support groups.

On a motion by Mr. Powell, seconded by Mr. Mills, the Board moved the tabled 6th grade teacher position from the previous August 27 meeting back to be considered for employment. On a motion by Mr. Powell, seconded by Mr. Brainard the Board employed Kristin Reeder as 6th grade teacher, WCMS.

On a motion by Mr. Powell, seconded by Mr. Brainard, the Board authorized a Data Management Specialist, WCPC, extra duty contract for a salary of \$5,000 per year, subject to the availability of federal funds.
