## MINUTES OF THE WIRT COUNTY BOARD OF EDUCATION

August 13, 2013

The Wirt County Board of Education met in their regular session on Tuesday, August 13, 2013 in the Wirt County High School cafeteria. Present were James Rader, President, Carl Brainard, Vice President, Mark Lowe, and Chuck Mills, Edward Powell, members, Daniel Metz, Superintendent, and Karen Cummings, Treasurer.
