Mr. Metz, called the meeting to order at 6:00 pm. The Pledge of Allegiance was led by Ashley Gunnoe, Morgan Roberts, Jamie Vannoy, Teachers, Wirt County Primary Center.

On a motion by Mr. Lowe, the Board approved the agenda with changes by unanimous consent.

The Board received Benchmark Data for Wirt County Primary Center. The presentation was given by Melissa Emerson, Principal, WCPC, Ashley Gunnoe, Morgan Roberts, Jamie Vannoy, Teachers, WCPC and Brandi Keaton, former Special Education Teacher.
