Sycamore Park Elementary School will:

Provide and implement the following benefits and support as feasible with the restrictions implemented with the Covid-19 pandemic.

Sycamore Park will utilize various forms of communication, including digital to provide information and support to our Families to meet our beneficial title I Family engagement activities goals.

- A. <u>Sycamore Park</u> will jointly develop/revise with parents the school Parent and Family Engagement policy/procedures and distribute it to parents of participating children and make available the Parent and Family Engagement policy/procedures to the local community.
 - Policy updates will be shared with the Parent Advisory Committee (PAC) for feedback and will be finalized with all stakeholders by September of each year.
 - The policy will be available on the school's website by August of each year.
 - The policy will be discussed and reviewed with all stakeholders during school-wide events beginning in September and continuing throughout the school year.
- B. Convene an annual meeting, at a convenient time, to which all parents of participating children shall be invited and encouraged to attend, to inform parents of their school's participation under this part and to explain the requirements of this part, and the right of the parents to be involved.
 - Meet the Teacher and Back to School Night will include a presentation on Title 1 school-wide programs, requirements and parent rights. Pamphlets containing the information will be available to all parents in a language they can understand. This information will continue to be available to parents throughout the school year and will be posted on the school's website.
- C. Offer flexible meetings, such as meetings in the morning or evening, and provide, with funds provided under this part, transportation, child care, or home visits, as such services related to Parent and Family Engagement.
 - Four (4) "Teachers Involving Parents" (TIP) meetings will offered at various times to accommodate parents. Topics will include, but not limited to, "Preparing Your Child for the Spring Virginia Standards of Learning Tests," "Helping Your Child with Homework," and "Reading to Your Child;" Translators will be available as necessary and child care will be provided for at least one of the evening events.
- D. Involve parents, in an organized, ongoing, and timely way, in the planning, review, and improvement of the school plan under Section 1112, schoolwide under Section 1114, and the process of the school review and improvement under Section 1116.
 - Parent Advisory meetings (PAC) will occur four times a year.
- E. Provide parents of participating children—

- 1. Timely information about programs under this part.
- 2. A description and explanation of the curriculum in use at the school, the forms of academic assessment used to measure student progress, and the proficiency levels students are expected to meet.
- 3. If requested by parents, opportunities for regular meetings to formulate suggestions and to participate, as appropriate, in decisions relating to the education of their children, and respond to any such suggestions as soon as practically possible.
 - In September the school will hold a back to school night to include a presentation on Title I school-wide programs, requirements and parent rights. Pamphlets containing the information will be available to all parents in a language they can understand. This information will continue to be available to parents throughout the school year and will be posted on the school's website.
 - By October, parents, teachers and students will sign Title I school compacts.
 - By October, families will be surveyed on workshops they would like to be offered during the school year to include time and location preferences.
 - Annually, families will be invited to participate in the Title I, Part A survey.
- F. If schoolwide program plan is not satisfactory to the parents of participating children, submit any parent comments on the plan when the school makes the plan available to the district.
 - During the PAC meetings, parents will be given the opportunity to offer feedback and approve the Title I school-wide plan. If a parent is not satisfied with the jointly developed plan, their comments will be included when the plan is submitted to the division.
