### CALL TO ORDER:

Co Chairperson Moore called the meeting to order at 10:40 A.M.

**APPROVAL OF MINUTES:** Co Chairperson Moore asked for a motion concerning the minutes of the January 10, 2007 meeting. Dean Dietrich indicated that he would like to amend his counter proposal as stated on the top of page 3 to omit the last two bullets and add "The spokesperson did give information which suggested that a 10% increase in premiums was a reasonable increase". Stephanie Bannon also indicated that an error had been made on page 4 which should have stated the groups would meet from 9:00 AM to 10:00 AM and not 10:00 PM. With the corrections presented, Paul Harrica moved, moved, seconded by Dana Wood that the minutes be approved.

## PLAN 2007-2010:

**DISCUSSION OF HEALTH** Dean Dietrich stated that the Employee Group had a counter proposal as follows:

- \$200,000 cost shift for 3 years
- Extend moratorium for 3 years
- Seriously consider a PPO for future
- Premium contributions by employees can not be discussed

Co Chair Bower reviewed information from the Keiser Family Foundation which stated that the nationwide average premiums paid by employees was 16% for single coverage and 27% for family coverage.

The Employer Group requested a caucus at 11:05 A.M. They returned at 11:15 A.M.

Co Chair Bower distributed copies of Selected Options for Joint Governing Board Consideration. Mr. Bower stated that Options A & B were partial payment of premiums and C & D were plan design changes. He also indicated that if the Employee Group could come up with \$1,000,000 per year based on any of the options given, the Employer Group would consider extending the moratorium for three years.

The Employee Group requested a caucus at 11:25 A.M. They returned at 12:10 P.M.

Dean Dietrich indicated that the Employee Group had moved twice showing a sincere effort to find a resolution and offered the following proposal:

- Extend moratorium for 3 years
- Discuss PPO for future
- Moved toward a \$300,000 employee cost

Lunch was served at 12:15 P.M. Meeting resumed at 1:45 P.M.

Co Chair Bower indicated that while the Employee Group was disappointed in the Employer Group offer, the Employer Group was finding it difficult to understand how an offer by the Employee Group to move toward a \$300,000 employee cost compared with previous discussions of maintaining current employee cost share, which would take about \$700,000. Dan Bower indicated that in an attempt to continue the discussion, the Employer Group would adjust the previous offer down to \$900,000 in cost savings from the employees. If the Employer Group was interested in discussing options which included less than \$900,000 in cost savings, they must contain premium contribution or the moratorium will expire on June 30, 2007.

The Employee Group requested a caucus at 1:50 P.M. They returned at 2:15 P.M.

Dean Dietrich indicated that after discussing the proposal presented, the Employee Group has accepted the end of the moratorium as of June 30, 2007.
