- 6) The Board is asked to approve, reject, or table the Superintendent's recommendation to hire an elementary teacher for the 2022-23 school year on a temporary contract pending background check and employment clearances with the SDE.
- 7) The Board is asked to approve, reject, or table the Superintendent's

recommendation to hire a paraprofessional.

8) The Board is asked to approve, reject, or table the Superintendent's recommendation to hire a part-time maintenance person for school year 2022-23 on a temporary contract.
