- 10) It is recommended that the Board approve the "Legal Notice" of the district that the annual election filing period for candidates will open at 8:00 a.m. on Monday, December 5th, 2022 and closes at 5pm on Wednesday, December 7th, 2022 for board position #3 for a five year term. A Board of Education Primary Election shall be held on February 14th, 2023, only if three or more candidates file for the Board of Education position appearing on the ballot as an unexpired term. A Board of Education General Election shall be held on April 4th, 2023 under the following circumstances: if only two candidates file for a position scheduled to be on the ballot or for a position on the ballot for an unexpired term or if no candidate in the Board of Education Primary Election receives more than 50% of the votes cast. The polling places shall be open from 7:00 a.m. to 7:00 p.m.
