#### **NEW VISION GOVERNMENT AND LAW**

The New Vision Government and Law Program is an academically rigorous program for college-bound seniors who plan to major in pre-law, political science or criminal justice. New Vision students learn and work in a professional setting alongside lawyers, court officials, law enforcement and a wide range of other legal professionals. The academic curriculum is combined with an experiential rotation to provide students with a rich and rewarding learning opportunity.

The program is located in close proximity to lawyer's offices, Franklin County courthouse and the law library.

#### **Objectives of Program**

Students are introduced to the skills and responsibilities associated within this field. During the course of the year, the students will:

- Learn fundamental concepts and techniques used by attorneys and courts in analyzing cases, interpreting statutes and determining disputes.
- Study jurisdictional authority and how it is applied at the local, county, state and federal level.
- Analyze fact situations in depth and be able to organize and argue points-of-view both verbally and in writing.
- Interact with guest lecturers from federal and state law enforcement agencies, judges and lawyers.
- Research and argue landmark and current legal issues in first and appellate level court situations.
- Public Speaking—Develop and enhance public speaking techniques in a variety of settings.
