Consideration of Capital Improvements

Approval for the following Projects was requested of the Board:

- Approval of Hafer & Associates Fees (SHS Restroom Renovations/Science Lab Renovations, Carlisle HVAC Piping, Athletic Restroom Renovations – Baseball/Softball/Soccer - \$36,000
- Approval of Auditorium Safety Improvements Associated Controls & Design – Safety items \$50,000 – Curtains - \$22,000
- McKinley Trenching Installation of Water/Sewer Line Baseball Field -\$11,012.00

Approval was granted upon a motion by Jerry Wilson, second by Jon Bobbitt, and a 4-0 vote of the Board.

Approval of Policy Change to Middle School Athletic Eligibility

Superintendent Stitzle asked the Board to approve a policy change to middle school athletic eligibility. This policy change would implement the IHSAA eligibility policy at both middle schools. Currently the schools have two different policies. As part of this recommendation, he asked the Board to waive the two readings required for policy changes. The proposed policy change was approved upon a motion by Jerry Wilson, second by Barb Rotramel and a 4-0 vote of the Board.

Approval of Staff Professional Development Option

Superintendent Stitzle stated that Equitable Education Solutions would provide a library of professional development opportunities that our Building Principals could use to support our teaching staff. The cost is \$5,000 annually. He asked the Board's approval tonight and after a final discussion with the Principals at the next Leadership Team Meeting scheduled on Thursday, November 15, 2018, he would then execute the contract for these services. This was approved upon a motion by Barb Rotramel, second by Jerry Wilson, and a 4-0 vote of the Board.

Consideration of Non-Certified Salary Increases

Superintendent Stitzle recommended a 2.5% salary increase for all non-certified staff for 2019 and a \$500.00 stipend for all non-certified contracted employees. This was approved upon a motion by Jon Bobbitt, second by Jerry Wilson, and a 4-0 vote of the Board.
