Minutes

A motion was made by Dr. De Vita to accept the minutes of December 18, 2014. 2nd by Mr. Hemm. Motion passed 4-0.

Chairman's Report

Mr. Kohlman reported that the Board of Selectmen had recently appointed a Coolidge Re-Use Committee.

Superintendent's Report

The central office move from the Coolidge School to the Fowler School began on December 29th. There will still be some unpacking to do for quite some time but we are open for business in the new year. We operate as our own electronically secured building within the Fowler School and would ask that all visitors come to the Tiger Drive 3-R entrance on the right side of the building.

Dr. Gerardi also reported that there were recent changes made to the MPS web home page. Mr. Kohlman reported that the school committee meeting schedule needed to be changed and some parents cannot access their iPass accounts using Internet Explorer.

Maynard Bromfield Co-Op Non-Renewal

Maynard High School athletic programs are competitively placed by MIAA based upon census. In regard to MHS football, all of our male students at MHS are counted (approximately 225 this year) and half of Bromfield's male students are counted (approximately 210 this year) for a total census of about 435 eligible football players. Based on this 435 figure the team is scheduled to move up to MidWach Division C, up from D, this coming year and then fully into Division 5

from 6 statewide. Both Kevin Caruso and Coach Ogilvie do not believe that this is in the best interest of our athletic program.

Maynard High generated 30 of the 36 players this year. Bromfield has 6 players despite the census figures being roughly equal for MIAA counting purposes. Over the 4 years of Co-op play the Bromfield contribution has dropped from 13 to 9 to 7 to 6. The trend is not going in a supportive direction as we anticipate as few as 4 Bromfield players this coming year should the co-op be renewed. To be at a competitive disadvantage because of a census figure that does not reflect the actual number of student-athletes coming from Bromfield does not make sense for the Maynard athletic program. The existing 4 Bromfield students would be grandfathered in.

A motion was made by Mr. Hemm to approve the non-renewal of the football cooperative agreement with Bromfield. 2nd by Dr. De Vita. Motion passed 4-0.

Student, Teacher, and Administrator Travel/Learning Opportunities through EF Tours
International Program Coordinator, Kevin Caruso, has been investigating international travel opportunities for students during the summer, similar to trips that he has run for MHS in the past. He is in the process of developing a student trip for the summer of 2016. He has already surveyed the foreign exchange students for travel ideas from their country of origin as an attempt to possibly link our Maynard student travel programs with our foreign exchange programs.

These opportunities will be discussed at the next MLT meeting to determine if there is interest from our administration to organize a trip or trips that would benefit several of our teachers or administrators from Maynard. If there is interest, these ideas will be introduced to other educators in our AVC & CASE collaborative or the GS 21 group of communities.

Innovation and the Future of Education - June, 2015

Dr. Gerardi was invited by Tony Bent, the MASS GS 21 Instructor, to attend the Future of Education Summit Conference in Davos, Switzerland in June, 2015.

Dr. Gerardi's participation will provide our district with the knowledge and opportunity for Maynard students and teachers to participate in this annual conference in the future. The process of having students solve pressing global issues was studied last year at my GS 21 professional development. I would like to see these types of activities integrated into our STEM and Senior project initiatives in the future.

A motion was made by Dr. De Vita to approve Dr. Gerardi's conference in Davos, Switzerland from June 24-28, 2015 at a cost of \$1600. 2nd by Mr. Hemm. Motion passed 4-0.

A motion was made by Dr. De Vita to transfer the Coolidge School Building and property to the care, custody, management and control to the Board of Selectmen. 2nd by Mr. Hemm. Motion passed 4-0.
