\_\_\_ 3<sup>rd</sup> offense -Student must complete intervention program with certified addiction counselor prior to reinstatement. *(court assigned counseling sessions count towards this requirement)*

**(the school will NEED written confirmation indicating the completion of the 6 or 12 hour intervention/counseling program)**

## **Category 3: Currently participating in extra-curricular events:**

### **PART A**

**(the school will NEED written confirmation indicating the completion of the 6 or 12 hour intervention program)**

## Category 4: Mere Presence Violation:

\_\_ 1<sup>st</sup> offense – 2 week or 2 events whichever is greater (beginning the day administration is notified)

\_\_ 2<sup>nd</sup> offense – 6 week or 6 event, whichever is greater (beginning the day administration is notified)

\_\_ 3<sup>rd</sup> offense – 18 week or 18 events whichever is greater (beginning the day administration is notified)

**A student must remain in the sport for the season for consequences to count, this does carry over from year to year until the consequences have been appropriately served.**
