Folsom Vision

Budget Highlights

- Maintains High Quality Education for Folsom Students.
- Increases Cost Per Equalized Pupil 4% from \$17,653 to \$18,735.
- Increased number of High School Tuition Students.
- Common Level of Appraisal Decreased 8.96% (97.28 to 88.32). If the CLA had remained the same, the tax rate would have decreased.
- Folsom enrollment trending upward with CIUUSD tuition students.
- Federal Grant money covering some General Expenses.
- Increase Art Teacher FTE from .8 to 1.0 through savings in General Expenses.
- Added Theater Director stipend through savings in General Expenses.

The impact of interrupted school, stress, and anxiety on children is challenging to measure. EQUALIZED PUPILS*

Not to be confused with the number of students in the school district or the enrollment at Folsom, the Equalized Pupil count is the weighted average number of pupils PreK-12. This number is determined by the state. It is the number used for the Homestead Tax rate calculation.

^{*} Equalized pupils are based on two years of Average Daily Membership data(ADM). The ADM is the full-time equivalent of resident students whose education is paid for by the district of residence, from the 11th day through the 30th day of the school year. A two year average is used to smooth out annual student population fluctuations in school districts.





This is the ratio applied by the state to equalize local grand lists to reflect market conditions for property value. It is established annually by the Vermont Department of Taxes. This is necessary because we start with a statewide tax rate and that rate is modified to reflect the local housing market. A value of less than 100 indicates that on average properties are being sold for more than the local assessment. A reduction in the CLA results in an increase in the actual tax rate.

The Property Tax Formula

•EXPENDITURES

\$4,273,850

• Expenditures are the total dollars a school district intends to spend.

•MINUS LOCAL REVENUES

\$516,478

• Local revenues are money the district has or is owed (e.g., federal dollars, state aid for special education, transportation, tuitions, surplus, interest).

•EDUCATION SPENDING

\$3,757,373

• Education spending is the amount that needs to be raised by education property taxes, augmented by the Education Fund.

•DIVIDED BY EQUALIZED PUPILS

200.55

Equalized pupils is a two-year weighted average.

•ED SPENDING PER EQUALIZED PUPIL

\$18,735

• Ed spending divided by equalized pupils.

•PROPERTY TAX YIELD PER \$1 OF TAX RATE \$12,937

 Formerly referred to as the Base Amount, which is set by the state and used to compare to a district's education spending per equalized pupil.

•EQUALIZED TAX RATE TO BE PRORATED \$1.4482

Ed spending per equalized pupil divided by property tax yield

COMMON LEVEL OF APPRAISAL

• CLA is the ratio of the town's listed property values versus the state's estimated values. The state's value is set by actual sales averaged over three years.


ACTUAL HOMESTEAD TAX RATE

South Hero

\$1.6397

• Equalized tax rate divided by the CLA. This is multiplied by the assessed value of your home and divided by 100. The resulting education tax is added to the municipal tax to calculate your total property tax due.

INCOME SENSITIVITY

- Taxes based on income instead of property value.
 - Tax liability can be based on taxable income for household income up to \$136,900 for 2021.
- You must apply for a property tax adjustment.

•ACTUAL NON-HOMESTEAD TAX RATE

•Non homestead base rate divided by CLA. The resulting non-homestead rate is multiplied by the assessed value, divided by 100, and added to the municipal tax to determine your non-homestead property tax.
