- Principal Ross discussed the schedule for the 2017-18 school year and potential time changes
- Two letters of interest for the board vacancy have been received by the ACEC board
- Building Update: Principal Ross discussed areas in need of attention (painting, tile in hallways, walkways)
- Graduation will be held Thursday June 15, 2017. Friday will be a full day for students. Monday and Tuesday of the following week will be in-service days for staff.
- ACT 46 Update: legislation changes may be occurring to allow a side-by-side to be created with an already merged district, provided the school can prove geographic isolation. The merged district would receive Act 46 incentives in that case; Alburgh would not.

- Revised Alburgh Community Education Center Official Warning states: Shall the voters of the school district approve the school board to expend \$5,611,188.00 which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$15,799 per equalized pupil. This projected spending per equalized pupil is 5.46% higher than spending for the current year. An informational meeting will be held on May 1, 2017 at 7:00 pm at ACEC. Voting will commence May 2, 2017 from 7:00 am to 7:00 pm (signed by ACEC board members)
