VSBA Governance Presentation:

Andy Julow introduced Harry Frank from VSBA. Harry Frank gave some background on himself and what he understood about our district. He provided the board members with a handout titled "Good Governance". This handout outlined: Vision, Mission, Goals; Strategic Plan; Work Plans.
