PRINCIPAL'S REPORT.

Our opening local in-service day was structured about systems level work related to instructional block and intervention block planning. Outcomes of this work include 2.5 hours of intervention blocks across the school day at the K-1, 2, 3-4,5,6-8 grades. These configurations allow for the greatest number of resources to be available for I-time blocks, along with providing the flexibility to have our math specialist, Erin Oliver, support teaching and learning at the classroom level up to 3 hours per day.

The 6-8 grade bands has completed all BOY (beginning of year) assessments

Greg Hayes has accepted the home-school/student support position. Greg has extensive experience in leadership and teaching.

Enrollment is at 183.
