SUPERINTENDENT'S REPORT.

Barbara Burrington's report included:

- 1. Updates: nine GISU staff members attended the grand funded, National SWIFT Professional Learning institute in Arlington, Virginia. It was a very informative conference.
- ESSA Public Input Retreat: The AOE hosted a two-day retreat, August 10 and 11 at Jay Peak Resort to facilitate public input for the statewide ESSA Implementation Plan. All administrators will be meeting for 3 days in August the 8th, 9th and the 22nd to complete inservice plans.
- 3. Curriculum Development and Professional Learning: The leadership team is working on short and long-term professional learning.
- 4. From the Business Office: The audit preparation, information is being gathered and general ledgers will go to the auditors on August 16th. They will start their fieldwork on August 29th.

PRINCIPAL'S REPORT.

Mr. Arnzen discussed the conference in Arlington, Virginia. The theme of this conference was "Better Together".

Interviews will be held Monday, August 15th for Home-School/Student Supports position. This position has been expanded from the DEN coordinator's position. There are 12 applicants. Mr. Arnzen shared the draft job description based on the existing work and expanding that based on the model that is in place at regional schools.

Currently 18 students are enrolled. 1 at Milton High School. There are 29 students at South Burlington currently. Incoming 9th graders for FY17 @ 15. In-state private enrollment is @ 4. Out of state private enrollment is @ 1.

Pre-K enrollment. We budgeted for 25 students, but there are 35. That is a \$30,920 increase. Gary Marckres as Beth Hemingway to verify the numbers one more time.
