Board Discussion:

Skip Prairie discussed the window installations needed at ACEC. The cost estimate presented is 13,000.00. Skip Prairie left the plans and contract for board review

- Lynn Carpenter presented the budget to actuals and summarized overages and under budgeted line items
- David Epstein, an architect who specializes in school construction, met with Mr. Ross and made some renovation suggestions that would increase the security of ACEC. He also discussed the outside infrastructure and suggested ways to reduce ice accumulation in the cooler months. Mike Savage is going to contact Mr. Epstein and invite him to present to the board
- Mr. Ross presented a proposal composed by PATH Wellness and Matt Spear, for \$3,675.00 for revitalizing the track. This would be funded by PATH
- Rise Vermont proposes putting a "Ga Ga Court" on the ACEC campus which it will fund
- Mr. Ross also proposed the creation of raised garden beds to be funded through the town budget for afterschool programming at ACEC
