- Budget reduction of \$58,000.00

- Trevor Creller moved to warn the school budget of \$5,952,187.68 for FY 2016-17 to be voted on by the Alburgh citizens on Tuesday, April 12, 2016. The proposed spending per equalized pupil is 1.2492% higher than spending for the current year. The per pupil expenditure will be \$14,981.58. An informational meeting will be held on Saturday, April 9, 2016 at 10:00 am in the school gymnasium. (2nd John Goodrich) Unan.
- John Goodrich moved that the board, pending a written request, accept a cafeteria worker's request for a reduction in hours from 1.0 FTE to .6 FTE for School Year 2016-2017. (2nd Trevor Creller) Unan.
- Mr. Goodrich volunteered to review accounts payable prior to all school board meetings with the understanding that Administration will review accounts on request by Mr. Goodrich.
- Jennie Lund moved to authorize John Goodrich review and approve the accounts payable at his discretion (2nd Trevor Creller) Unan.
