# PRINCIPAL'S REPORT

# Teaching & Learning

Mr. Arnzen had the opportunity to visit middle school classrooms and speak to the teachers about what's going on in the curriculum. He reported back to the board on some of the topics students are currently learning about.

#### Science NECAPS

Results are being reviewed. The next steps at the leadership meeting will be to determine what questions this data answers and to follow a cohort of students over time. The long term objective is to use these results to affect curriculum. Teri will work with Eric to create a graph of NECAP results over time. Eric clarified that while the NECAPS have been replaced by the SBAC's in other subject areas, but not Science. Even with the New Generation Science Standards, the NECAPS will still be used.

#### **Facilities**

When disassembling the wood chip burner, it was discovered that the gear box within the unit was damaged. As the damaged unit was over 20 years old, Mr. Arnzen ordered a new gearbox for \$2200. In addition, he ordered a snow blower for the school to replace one that is no longer sufficient.

# **SBAC Results**

Mr. Arnzen and other staff attended a SBAC workshop on the 19th. It was somewhat disappointing, but they did learn that the proficiency levels are fairly vulnerable, and that major decisions should not be

made based off of percent scores. Instead, attention should be paid to growth over time, with this year being the baseline.

# Act 46 Committee Update

Teri distributed minutes from the last Act 46 Study Committee meeting. The next meeting has two purposes: to go over suggested survey questions to pose to the public, and review data points. A public forum will be held November 14 at Grand Isle School. Carol, Teri, Mike and Gary plan to attend the meeting on Oct. 27.

#### **Tax Anticipation Note Discussion**

Lynn Carpenter was not in attendance, so Gary Marckres said that he would reach out in order to discuss the tax anticipation note. Later in the meeting, Mr. Arnzen shared that he had received information from Lynn Carpenter via email saying that the town clerk said that money could be transferred so that it was not necessary to borrow.

### BOARD CORRESPONDENCE/SHARING

Gary Marckres said that the appearance of the school has greatly improved since Eric Arnzen became principal, and began hiring the right people for maintenance. He asked that this message be passed along.
