May parents appeal if their applications are denied?

Parents whose applications are denied may appeal to the DPI within 30 days after receiving the notice of denial. Late appeals cannot be accepted. The statutes require the DPI to uphold a school district's decision unless the DPI finds that the decision was arbitrary or unreasonable. The DPI's decisions may be appealed to circuit court.

Must students reapply every year?

Once a student is accepted into the nonresident school district, the student may continue to attend the district without having to reapply every year, with three exceptions:

- The nonresident district may require each student to reapply one time and one time only—at the beginning of middle school, junior high school, or high school. **The School District of Mondovi does not require reapplication for open enrollment at any grade level.**
- A student may be returned to the resident district if the special education required in a new or revised IEP is not available in the nonresident district or if there is no space.

- A pupil who has become habitually truant in the nonresident district may be returned to the resident district.

A student who is attending a nonresident school district under open enrollment may return to her or his resident school district at any time, by notifying both school districts that the student will be returning. However, once the student returns to the resident district, the student may not go back to the nonresident district unless the student reapplies during the next February application period. (Students should be aware that returning to the resident district may affect their eligibility for inter-scholastic athletics.)

Is there a cost to parents for participating in open enrollment?

There is no tuition cost to parents for their childrens’ participation in open enrollment. Instead, a per student amount will “follow” the student from the resident school district to the nonresident school district. Parents of open enrollment students may be charged the same fees as resident students (for example: book fees, towel fees, extra-curricular activity fees).

IMPORTANT DATES FOR OPEN ENROLLMENT

- Feb 6-April 28, 2017** Parents must apply to the nonresident school districts during this time period but not later than 4:00 p.m. on Friday, April 28, 2017. (A postmark does not meet this requirement. The time period may not be extended for any purpose.)
- June 9, 2017** By this date, school districts must notify parents of acceptance or rejection of application. Parents may appeal a rejection within 30 days of receiving the notice of denial.
- June 16, 2017** By this date, school districts must notify parents of accepted applicants of the school or program to which the student is assigned.
- June 30, 2017** Parents of accepted applicants must notify nonresident school districts whether the student will attend the nonresident school district in the 2017-2018 school year. (If the parent fails to make this notification, the student may not participate in open enrollment)
