Position Purpose:

This position is responsible for the oversight of the installation, maintenance and repair of technology equipment and software for the purpose of continued function and enhancement of technology in the education environment. This position also provides local management of the NCESD Network System.

Job Qualifications: Education and Experience:

Minimum of a High School diploma or equivalent required; BS/MS or Vocational Certification in Technology preferred. Will consider documented experience or certification programs, internships, or applied experiences in complex computer environments

- At least three years of recent experience working in the support of computers, servers, and LANs
- One additional CompTIA certification or equivalent (e.g., Network+, Linux+, or Server+)
- Advanced working knowledge of Windows, Apple, DOS, and Linux
- Advanced technical expertise with the setup and operation of technology hardware and software
- Ability to work independently and with students and staff in a team setting
- Advanced knowledge of network and communication systems
- Ability to communicate and implement effective problem-solving techniques
- To perform job successfully, an individual must be able to perform each essential duty satisfactorily
- Ability to effectively manage several on-going projects at one time.

9. Develops and organizes documentation of technology operations for peer and customer use
10. Assists with management of data back-up processes
