President Quackenbush read a statement that advance notice of this meeting, as well as the Agenda, had been distributed in accordance with the provisions of Chapter 231, Laws of 1975 (Sunshine Law).

Mr. Watson led discussion on:

1. ROD Grant for roof work

There are six (6) roof projects planned
State Share (40%) \$2,153,014
Local Share (60%) \$3,229,520
Total \$5,382,534

The recommendation is to go for a November 2014 Referendum.

The Referendum is appropriate to fund local share.

The Board unanimously agreed to move to have a November Referendum for Roof Projects.

2. Building Program at Westmoreland

Project cost is \$4,420,272 (10,800 sq. ft.)

not including architect, bond attorney, financial advisor and Board attorney fees. Recommendation is to expand this plan by 2 classrooms.

May 15th –LAN Associates proposal to expand the Westmoreland plan by 2 more classrooms and 4 more classrooms will be presented.
