- 4. What will be your top 3 objectives should you be selected to join the Fair Lawn Board of Ed?
- 5. There are a lot of pressing issues to public education and this Board. This appointment will require knowledge of them for an ability to work on those issues immediately. Based on what you know about recent board meetings, what do you feel those issues are and what is your opinion of them?
- 6. Why do you want to serve on the Board of Education?
- 7. The position of member of the Board of Education is an unpaid community service position. What experiences have you had providing community service.
