Board Comments

Policy #0155 was discussed and suggestions for change were made. Clarification on the direction of the Special Education Committee was requested. The administration and chairperson will set the agenda that is mutually agreed upon. Committee descriptions and definitions will be addressed further. A future meeting with Mr. Barbarulo, Ms. Quackenbush, Mr. Rosenberg and Mr. Norcia will be held to review the Education and Special Education Committee definitions. A discussion regarding the topics for committee consideration took place and the suggested language will be sent to the Board for review.

Governance by policy was briefly discussed. The Board voted with 6 thumbs up to move on to another topic.

Parliamentary procedure was discussed; materials provided at the Board Retreat were referenced. It was stated that Robert's Rules should be followed.

Goal #3 - A suggestion was made to streamline liaisons to the various legislative agencies for more productive results. Time commitments were brought up. Clarification that the Bergen County School Board Association (BCSBA) and New Jersey School Board Association (NJSBA) representatives would be combined with the Legislative Representative being the backup or alternate.

Goal #4 - Discussion took place. It was suggested that after this current budget season, the administration would give the Board Members the opportunity to voice their suggestions. They would have a small subset of Board Members take the feedback of suggestions to the administration and from there that committee would report back to the full Board.

Dr. Cohen requested a strawpoll for taking the survey, small subset, and reporting back to the full Board. 8 thumbs up were given.

<u>Goal #2</u> - The Board self-evaluation was suggested as a good starting point. Three ideas were presented for self-evaluation as follows:

- 1. Discuss goal #2 in the context of Board self-evaluation.
- 2. Reflect on how goal-related processes in 2019-2020 worked out and discuss the priorities for moving forward (in July or soon thereafter).
- 3. Do #2 sooner rather than later.

Discussion took place.

Strawpoll taken. Only two Board Members were in favor.

Time involvement and comments, working together as a Board and the time commitment of the Board of Education Members were discussed.

Questions were asked about the Board Committee Members and the Committee List as well as Board reports, FLEA dialogue and a position in the weight room to be considered for the budget. Parking lots and van questions were posed.
