# The Action of the Board

### 5.0 Action Item:

The Board of Trustees of Fruitland School District 373 has found that Student "A" has violated the policies, rules, and regulations of the Fruitland School District 373. As a result of this action student "A" is in violation of Idaho Code 33-205.

WHEREFORE, the Board of Trustees of Fruitland School District 373 hereby renders its decision to expel Student "A" from Fruitland School District 373 for the 2021-2022 school year. The Superintendent is hereby directed to, within five (5) days of this decision, give written notice of the student's expulsion to the prosecuting attorney of Payette County and/or take such other steps as are necessary under the requirements of the Idaho Juvenile Corrections Act with respect to this student.

The student and/or parent may seek to obtain reinstatement of Student "A" prior to the commencement of the <u>2022-2023</u> school year. Prior to such time we would ask that you communicate with the District's Office to address what process will be required for this consideration.

During the period of expulsion, Student "A" shall not be present upon any District property or at any District activity, regardless of location, absent pre-authorization of the District's Administration. If the Administration allows for Student "A" to attend an individual event(s), the Administration may place conditions on this attendance.
