Call Meeting to Order	<b><u>1.0 Call Meeting to Order:</u></b> The special board meeting was called to order @ 6:15 p.m. by Trustee Hurrle.  <b><u>2.0 Pledge of Allegiance:</u></b> Trustee Hurrle led those in attendance in the Pledge of Allegiance.
Approval of Board Agenda	<b><u>3.0 Approval of Board Agenda:</u></b> A motion was made by Howell and seconded by Dressen to approve the board agenda as presented. The motion was unanimously approved.
Executive Session	<b><u>4.0 Executive Session:</u></b> <b>.1 Pursuant to Idaho Code 74-206 (1)(b) Student Discipline</b> <ul style="list-style-type: none"> <li>• <b>Student "D"</b></li> </ul> Trustee Howell made a motion to enter into executive session to consider the evaluation, dismissal or disciplining of, or to hear complaints or charges brought against, <b>Student "D"</b> under Idaho Code 74-206 (1)(b). The motion was seconded by Dressen.  Roll call vote was as follows: <ul style="list-style-type: none"> <li>* Layne Howell – yes</li> <li>* Aaron Dressen – yes</li> <li>* Matt Frye – yes</li> <li>* Debbie Hurrle – yes</li> </ul> Motion carried. The board convened into executive session at 6:16 p.m. Chairman Matt Frye joined Executive Session at 6:40 p.m.

**5.0 Action Item:**

.1 Possible action will be taken regarding Student Discipline.

- Student "D"

The Fruitland School Board has moved to expel Student "D" for a calendar year. Dates of the expulsion are from June 2, 2022 to June 2, 2023. The basis of this action is Student "D" violation of Idaho Code 33-205 whereas the "student's presence at school is detrimental to the health and safety of other pupils."

The Fruitland School Board has executed a "STAY" of expulsion starting June 2, 2022 providing the following conditions are met:

- Student "D" may return to school in the Fall semester of 2022 provided that he completes a "Threat Assessment" and is found not to be a danger at school. This assessment is to be in writing and provided to Superintendent Bayley prior to the start of the 2022-2023 school year.
- Student "D" behavior is within guidelines of school policy for the entire 2022-2023 school year, with none of the conditions outlined in Idaho Code 33-205 occurring in his discipline record. Items in 33-205 are:
  - Habitual Truancy.
  - Continuously disruptive to school discipline.
  - Presence at school is detrimental to the health and safety of other pupils.
  - Be in possession of a deadly or dangerous weapon or firearm on school property.
  - The student has engaged in violation of the reasonable terms and conditions of the board.
