

**THE REGULAR MEETING OF THE BOARD OF EDUCATION
NASHVILLE SCHOOL DISTRICT
September 17, 2012**

The Annual Report to the Public began with each of the following administrators reporting their common core; as well as school's enrollment figures, staff, programs, and testing: Shirley Wright, Principal-Nashville Primary; Paul Tollett, Principal-Nashville Elementary; Deb Tackett, Principal-Nashville Junior High; Tate Gordon, Principal- Nashville High; Kristi Cox, Gifted and Talented; Bunch Nichols, Transportation Director-826 miles a week, 1,140 bus riders; Joe Kell, Curriculum Coordinator- Federal and Local funds; Tina Conzel, Food Service Director-1,573 meals a day. The principals reported that Primary has 638 students, Elementary has 423, NJHS has 437, and NHS has 434 for a total of 1932. See attached outlines for all presentations.

The regular meeting of the Nashville School Board was called to order by President Phillip Turner at 7:20. Other members present were: Monica Clark, Mark Canaday , Randy Elliott, and Miles Mitchell.

Mr. Graham asked the board to approve the minutes from the previous regular meeting and a special meeting held August 23. Monica Clark made a motion to approve and Miles Mitchell seconded the motion. It passed 5-0.

In old business, Mr. Graham asked the board to approve Special Education Budgets for Federal Funds IVB and State and Local funds. Miles Mitchell made a motion to approve and Mark Canaday seconded the motion. It passed 5-0.

Mr. Graham presented Phillip Turner with a plaque recognizing his 10 years of service to the Nashville School District.

Mr. Graham stated that 29.5% of the budget has been spent and asked the board to approve the payment of the bills. Mark Canaday made a motion to approve and Randy Elliott seconded the motion. It passed 5-0.

Mr. Graham asked the board to approve the Athletic Budget and Expenditures. Mr. Graham explained that this is a new reporting formula dealing with square footage that must be published to the Web site. Miles Mitchell made a motion to approve and Mark Canaday seconded the motion. It passed 5-0.

Mr. Graham asked the board to approve the retirement of \$83,292.56 in fixed assets. Monica Clark made a motion to approve, and Randy Elliott seconded the motion. It passed 5-0.

Mr. Graham asked the board to approve the 2012-13 Migrant Application. Mark Canaday made a motion to approve and Miles Mitchell seconded the motion. It passed 5-0.

Mr. Graham asked the board to approve a Student Transfer. Miles Mitchell made a motion to accept and Mark Canaday seconded the motion. 5-0.

Mr. Graham asked the board to accept the resignation of Janet Jamison as an aide at Nashville Primary. Mark Canaday made a motion to accept and Randy Elliott seconded the motion. It passed 5-0.
