C. Reading Readiness and Civics Exam

The current law requiring districts to assess reading readiness using the Phonological Awareness for Literacy Screening (PALS) remains in place for the 2015-2016 school year. Beginning in the 2016-17 school year, PALS will no longer be administered

statewide. Instead, districts and charter school operators will select their own reading readiness screener and receive some funding for the use of that screener (funding is unknown at this time).

Beginning with the 2016-2017 school year, districts, charter operators, and private choice schools may not grant a high School diploma until the student successfully completes a civics test. Informational explanation included in report.

D. Badger 3-8 Exam and ACT Aspire and ACT Reports

All of the state testing results from the 2014-2015 school year continue to be publically embargoed until a public press release is issued, which has now been pushed back to by the end of the year. Results will be shared after that time. The embargo has been lifted to school personnel only.
