Motion by Kistenmacher, second by Aschinger to approved minutes of the regular board meeting of February 13, 2019. Motion carried unanimously.

Motion by Kalin, second by Johnson to approve summary list of bills as presented. Motion carried unanimously. (Bills reviewed by Kalin prior to board meeting)

Motion by Johnson, second by Aschinger to approve financial reports for month ending February 2019 as presented. Motion carried unanimously.

Motion by Kistenmacher, second by Johnson to approve the transportation billing as presented. Motion carried 7-0.

Motion by Johnson, second by Kalin to approve the hiring of Ashley Hunswardsen as a 4<sup>th</sup> grade teacher at BA, Step 0 with a salary of \$34,340.90 for the 2019-2020 school year. Motion carried 7-0.

Motion by Wittrock, second by Kistenmacher to approve the hiring of Ashley Shindoll as a special education aide at \$9.00 per hour. Motion carried unanimously.

Motion by Pribble, second by Johnson to approve the hiring of Bridget Drey as a Little Raptor Daycare employee at \$8.00 per hour. Motion carried 7-0.

Motion by Johnson, second by Aschinger to approve Resolution for Budget Guarantee as stated: FY2020: RESOLVED, that the Board of Directors of the Galva-Holstein

Community School District will levy property tax for fiscal year 2019-2020 for the regular program budget adjustment as allowed under section 257.14, <u>Code of Iowa</u>. Roll Call Vote: Ayes: Aschinger, Johnson, Kalin, Kistenmacher, Pribble, Whitmer, and Wittrock. Nays: none. Motion carried 7-0.

Motion by Kistenmacher, second by Aschinger to approve 2019-2020 School Calendar, as presented by Superintendent Wiebers with the addition of assigning April 13, 2020 as a snow make-up day if needed. School start day will be August 23, 2019 with projected last day of school May 22, 2020. Motion carried 7-0.

Motion by Aschinger, second by Kalin to approve Iowa High School boys and girls athletic sharing agreement for 2019-2020 school year. Motion carried unanimously.

Budget Hearing for the proposed 2019-2020 budget to be held on April 8, 2019 at 6:20pm in the Holstein Central Office.

Motion by Kistenmacher, second by Wittrock to approve the new 3-year internet service contract with ICN for \$525 per month. Motion carried 7-0.

Motion by Pribble, second by Aschinger to approve the Summer Dead Week as July 28 – through August 3 where the District's facilities will be closed and coaches will not have contact with athletes. The motion included allowing administration to set Dead Week at its discretion in future years without formal approval from the Board. Motion carried 6-1.

Motion by Kalin, second by Aschinger to approve the waiver for PE Standard Exemption for the 2018-2019 school year. Motion carried unanimously.

Motion by Aschinger, second by Kistenmacher to approve the bid for the upgraded wireless connection between Holstein and Galva with Xtreamair. Motion carried 7-0.

Motion by Johnson, second by Wittrock to approve the Financial Services Agreement with Piper Jaffrey to provide services in issuance of the 2019 and 2020 GO Bonds. Roll call vote: Ayes: Aschinger, Johnson, Kalin, Kistenmacher, Pribble, Whitmer, and Wittrock. Nays: None. Motion carried 7-0.

Motion by Pribble, second by Wittrock to approve Piper Jaffrey as the District's Dissemination Agent for secondary market disclosure for the 2019 and 2020 series bonds. Roll call vote: Ayes: Aschinger, Johnson, Kalin, Kistenmacher, Pribble, Whitmer, and Wittrock. Nays: None. Motion carried 7-0.

Director Wittrock introduced the following Resolution and moved its adoption. Director Kistenmacher seconded the motion to adopt. The roll was called and the vote was: Ayes: Aschinger, Johnson, Kalin, Kistenmacher, Pribble, Whitmer, and Wittrock. Nays: None. Motion carried 7-0.

President Whitmer declared the Resolution adopted as follows:

RESOLUTION AUTHORIZING THE ISSUANCE OF NOT TO EXCEED \$10,000,000 GENERAL OBLIGATION SCHOOL BONDS, SERIES 2019, AND LEVYING A TAX FOR THE PAYMENT THEREOF

WHEREAS, the Galva-Holstein Community School District, in the Counties of Ida, Cherokee, Buena Vista, and Sac, State of Iowa, is a public school corporation, organized and existing under the Constitution and laws of the State of Iowa, and is not affected by any special legislation; and

WHEREAS, the Board of Directors of the School District in accordance with Iowa Code chapter 296 received a petition, which was signed by qualified electors numbering at least 25% the voters voting at the last regular school election, asking that an election be called, and at a meeting called by the President of the Board of Directors, within ten days after receipt of the petition, called an election and submitted on December 11, 2018, the following proposition:

Shall the Board of Directors of the Galva-Holstein Community School District in the Counties of Ida, Cherokee, Buena Vista, and Sac, State of Iowa, be authorized to contract indebtedness and issue General Obligation Bonds in an amount not to exceed \$12,285,000 to provide funds to build, furnish, and equip an addition to the elementary/high school facility in Holstein, including a gymnasium, industrial tech facilities, classrooms, related remodeling and security improvements, and site improvements?

and gave notice of the election and of the proposition; and

WHEREAS, the election was conducted on the date and the proposition was legally submitted, approved and no contest was made; and

WHEREAS, none of the Bonds authorized at the election have been issued, and it is now necessary to issue not to exceed \$10,000,000 General Obligation School Bonds, Series 2019, and to levy a tax for the payment;

NOW, THEREFORE, IT IS RESOLVED BY THE BOARD OF DIRECTORS OF THE GALVA-HOLSTEIN COMMUNITY SCHOOL DISTRICT, IN THE COUNTIES OF IDA, CHEROKEE, BUENA VISTA, AND SAC, STATE OF IOWA:

Section 1. <u>Authorization of the Issuance of School Bonds</u>. School Bonds in the amount of not to exceed \$10,000,000 (the "Bonds") shall be issued pursuant to the provisions of Iowa Code chapter 296 for the purposes approved at the election of December 11, 2018. Additional action shall be taken by the Board of Directors to provide for the issuance of the Bonds upon the sale of the Bonds.

Section 2. <u>Levy of Annual Tax</u>. For the purpose of providing funds to pay the principal and interest of the Bonds authorized to be issued, there is levied for each fiscal year the following direct annual tax on all the taxable property in the Galva-Holstein Community School District, in the Counties of Ida, Cherokee, Buena Vista, and Sac, State of Iowa:

\*Based upon the terms of sale of the Bonds to be issued, this Board will take final action upon the sale of the Bonds to issue the Bonds by amendment to this Resolution ("Amended Resolution"). The Amended Resolution will provide for the assessment of an annual levy upon all the taxable property in the School District sufficient to pay the interest and principal of the Bonds within a period not exceeding twenty (20) years, and will be filed with the County Auditor of each County in which the School District is located. The filing provides that the Auditor annually levy for collection from the taxable property of the School District until funds are realized to pay the bonds in full.

A certified copy of this Resolution shall be filed with the County Auditors of the Counties of Ida, Cherokee, Buena Vista, and Sac, State of Iowa, who are instructed in and for each of the years, to levy, assess and collect the tax in the same manner as other taxes of the School District and, when collected, these taxes shall be used only for the purpose of paying principal and interest on the Bonds.

Principal and interest coming due at any time when the proceeds of the tax on hand are insufficient to pay the amount due shall be promptly paid when due from current funds of the District available for that purpose and reimbursement must be made.

PASSED AND APPROVED this 11th day of March, 2019.

Kistenmacher and Wittrock left the meeting (7:10 pm).

Reports were given by building principals Warnke and Cole.

Report was heard from Superintendent in which he confirmed that districts will receive a 2.06 percent increase in state aid for the 2019-2020 school year as signed by the governor. Also renewed for the 19-20 school year will be the transportation equity funding. Wiebers updated both boards on the construction projects going on in each district.

Motion by Johnson, second by Aschinger to adjourn. Motion carried 5-0.
