Motion by Kistenmacher, second by Aschinger to approve Resolution for Budget Guarantee as stated: FY2019: RESOLVED, that the Board of Directors of the Galva-Holstein Community School District will levy property tax for fiscal year 2018-2019 for the regular program budget adjustment as allowed under section 257.14, <u>Code of Iowa</u>.

Motion by Aschinger, second by Johnson to approve 2018-2019 School Calendar, as presented by Superintendent Wiebers with the addition of allowing flexibility regarding professional development on January 2. School start day will be August 23, 2018 with projected last day of school May 23, 2019. Motion carried 7-0.

Motion by Kistenmacher, second by Pribble to approve Iowa High School boys and girls athletic sharing agreement for 2018-2019 school year. Motion carried 7-0.

Budget Hearing for the proposed 2018-2019 budget to be held on April 9, 2018 at 5:30pm in the Holstein Conference Room.

Motion by Pribble, second by Johnson to approve Cooperative Agreement with UNI to have their student teachers and field experience teachers placed in our district. Motion carried unanimously.

Motion by Kalin, second by Kistenmacher to approve a 3-year contract with SRK Technologies to provide 50 hours of service each week between Galva-Holstein and Schaller-Crestland districts. The hourly rate is \$28 for a total of \$2426.80 paid by Galva Holstein each month. Motion carried 7-0.

Motion by Pribble, second by Johnson to approve annual contract with WITCC for concurrent enrollment of Great Start and Consortium offerings. Motion carried unanimously.

Motion by Kistenmacher, second by Aschinger to approve the recommendations of the District Technology Committee of purchases for the 2018-2019 school year in the amount of approximately \$23,625. Motion carried 7-0.

Report was heard from Superintendent in which he confirmed that districts will receive a 1 percent increase in state aid for the 2018-2019 school year as signed by the governor. Also approved was one-time funding for equity in transportation, which should amount to approximately \$60,000 for the district. The extension of operational sharing has yet to be approved and continues to cause concern.
