Topics and Discussion

1. Call to order: 5:15 pm.

2. Review/Acceptance of Minutes: Minutes from May 16, 2019 meeting were approved unanimously in a motion by Karl Terryberry, seconded by Tom Giles.

3. Invitation for Public Comment: None

- **4. Faculty Report:** Mr. Morrison spoke on Board development and handed out "What's Academic Excellence Committee" by Karrie Sundborn. He also spoke about the Faculty Senate, which was formed a year ago. The goal of the Faculty Senate is to address faculty concerns.
- **5. Parent Report:** Mr. Terryberry noted the positive feedback from parents about the National Honor Society induction and the teachers' involvement in the school.

7. Committee Reports:

- A) Academic: The Commandant said that Regents exams had begun this week.
- **B) Finance:** Karen Burhans from our accountant, Kirisits, presented the budget for the upcoming year. After discussion and Q and A, a motion was made by Mr. Giles to adopt the 2019-2020 budget, seconded by Ms. Crawley. Motion carried 8-0.
- **C)** Enrollment: The Commandant updated the Board on enrollment/application numbers for prospective students next year. Here is the breakdown: 7th Grade 28, 8th Grade 49, 9th Grade 81, 10th Grade 123, 11th Grade 104, 12th Grade 76.
- **D)** Executive: Mr. Comerford informed the Board that Maritime closed on the new school building at School #29. Funding and rehabilitation was to begin immediately.
- **E) Scholarship:** Tina Grady, widow of Angelo Conorozzo, drew the winning tickets. Proceeds for the Angelo Conorozzo Scholarship Fund were over \$5,000. Two \$2,000 scholarships will be awarded to deserving seniors.
- **8. Old Business:** Elections were held. All Board members will remain for the 2019-2020 school year. All officers shall remain the same, as well.

- **9. New Business:** Mr. Comerford passed out the Financial Disclosure Forms, Commandant Evaluation and Board Self Evaluations. They are due by the July 18, 2019 meeting.
