APPROVE A RESOLUTION ESTABLISHING A CAPITAL PROJECTS FUND UNDER REVISED CODE SECTION 5705.13(C) AND AUTHORIZING AND DIRECTING THE TRANSFER OF MONEY TO THAT FUND FROM THE GENERAL FUND IN THE AMOUNT OF \$300,000 IN FISCAL YEAR 2023.

WHEREAS, this Board of Education has determined that it is necessary and appropriate to accumulate resources generally for the acquisition, construction and improvements of fixed assets of the School District, and more specifically for stadium improvements, including new bleachers, lighting, electrical work, concrete work, etc. (the "Stadium Project"), with the expectation of additional funds being supplied by booster donations; and

WHEREAS, the Board desires to establish a capital projects fund as authorized by Section 5705.13(C) of the Revised Code for costs of the Stadium Project and to contribute money to that fund;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Western Reserve Local School District, Counties of Huron and Erie, State of Ohio, that:

Section 1. As authorized by Section 5705.13(C) of the Revised Code, the Board

hereby establishes a capital projects fund for the purpose of accumulating resources for the Stadium Project (the "Capital Projects Fund"). The source of money to be used to fund the Capital Projects Fund for the Stadium Project shall be lawfully available money in the District's General Fund. The amount of money to be accumulated for the Stadium Project shall be \$300,000, with the entire amount to be transferred in Fiscal Year 2023, as set forth in Section 2 below. Pursuant to Section 5705.13(C), should the Board so determine at a later point, the Board "may rescind a capital projects fund" and, in such case, "money that has accumulated in the fund shall be transferred to the fund or funds from which the money originally was transferred."

Section 2. The Treasurer is hereby authorized and directed to establish the Capital Projects Funds in the books and records of the School District and take any other such actions as are necessary and appropriate to effectuate this resolution. Consistently with the provisions of Sections 5705.13(C) and 5705.14(E) of the Revised Code, the Treasurer is specifically authorized and directed to promptly transfer the amount of \$300,000 from the District's General Fund to the Capital Projects Fund.

Section 3. This Board finds and determines that all formal actions of this Board and of any of its committees concerning and relating to the adoption of this Resolution were adopted, in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in those formal actions were held, in meetings open to the public, in compliance with the law.

Section 4. This Resolution shall be in full force and effect from and immediately upon its adoption.
