## Accident Waiver and Release of Liability

All waivers must be returned to Ms. Alisha Elder, in the main office, or Mrs. Perla Alarcon-Flory/Stacy Junge prior to Friday, May 5, 2023. Only upon submittal of this form, participants will receive tickets/passes to Grand March, Prom and/or After Prom.

**Regardless of the participants age, all waivers MUST be signed by a parent or guardian.** By signing this waiver both the Student and Parent/Guardian agree as follows:

- EHS Seniors and their guests participating in the Grand March must report by 3:30pm in the EHS Media Center.
- Participants will not be admitted entry to After Prom after 11:45pm
- Participants must remain until the end of the event, Sunday, May 7, 2023, 2:30am, per our insurance policy.
- EHS has a vape-free, drug-free, alcohol-free policy to which all guests are required to adhere.
- No outside food or drink will be brought into Prom or After Prom
  - I hereby grant permission for EHS personnel and/or authorized volunteers to search any tote bag, duffle bag, water bottle, etc. that is in participant's possession upon entering the facilities.
- Tickets/passes must be shown to enter the venues.
- All EHS students shall bring a current EHS ID, and all guests will bring a current ID for check in to all events.

I acknowledge that attendance at EHS Grand March, Prom, or After Prom involves risk. I hereby assume all risk associated with my or my child's participation in this event. I acknowledge that this Accident Waiver and Release of Liability form will be used by the venues and Sioux City Community School District (SCCSD) and will govern my actions and responsibilities at these events.

Assumption of Risk- The parent/guardian and student assume any and all risks, known or unknown, which may exist as a result of the student's participation in Grand March, Prom, After Prom, including but not limited to, traveling to/from, attendance, and participation in some or all of the events. In the event of an injury, the parent/guardian consents to any emergency medical treatment rendered to any student under the supervision of professional health care providers.

**Release of Organizers-** The parent/legal guardian and student voluntarily and expressly release and forever discharge SCCSD and all Prom and After Prom committee members from any and all liability, claims, damages, demands, or personal injuries which arise from or are in any way connected to the student's participation in Grand March, Prom, and After Prom, including those allegedly attributable negligent, reckless, or grossly negligent acts or omissions of SCCSD/committee members.

The parent/guardian and student acknowledge that they have had sufficient opportunity to read this entire waiver. The parent/guardian and student hereby acknowledge that both parties fully understand the content of this document and agree to abide by its terms.
