***ALL School Registration will be ONLINE** through our Marshall County School District Active Parent Website mcs.activeparent.net. Parents may register students online for the 2022-2023 school year: **March 1, 2022 through July 31, 2022.**

*Register your child through your Active Parent account mcs.activeparent.net. If you forget your username or password, please email the counselor.

***A registration access code will be required to register NEW STUDENTS.** Parents of New Students must contact the Counselor's office to obtain a registration access code at 662-838-2591 or via email: tabithagreer@mcschools.us

*If you want assistance to complete mandatory online school registration, you may come to the school during the dates/times listed below to access a computer and/or drop off proofs of residency.

Session 1: June 07-09 (Tuesday-Thursday) 08:30am-3:00pm

Session 2: July 19-20 (Tuesday - Wednesday) 08:30am-3:00pm

*****Please be mindful that ONLINE SCHOOL REGISTRATION is MANDATORY for ALL STUDENTS (NEW and RETURNING). Students who are not registered by July 30, 2022, will not receive a student schedule when school starts and will have to wait and register for school during late registration.**

PROOFS OF RESIDENCY

- Returning students do not have to provide proof of residency if their addresses have not changed.
- New students and returning students whose address has changed will still be required to prove residency as has been done in the past.

Required Documents for Registration:

*Two Proofs of Residency with current name and address

Documents/Bills must be dated June 1, 2022 or after

- Mortgage document, Property Deed, or Rental Lease Agreement
- OR
- Utility, Gas, Water, Electric, Garbage Bill, Car-Tag registration, or Car Insurance document
- OR
- Government document (TANIF, MEDICAID, CHILD SUPPORT, or any document issued by Department of Human Services)

*Parent/Guardian Driver's License - KINDERGARTEN & NEW STUDENTS

*Current Mississippi School Compliance Health Form 121 (Shot Record) – ALL KINDERGARTEN, 7TH GRADE, & NEW STUDENTS

*Student's Social Security Card- KINDERGARTEN & NEW STUDENTS

*Certified Birth Certificate (Not Mother's Copy) - KINDERGARTEN & NEW STUDENTS

* Final Report Card, Transcript, Discipline File from previous school - NEW STUDENTS ONLY

- If student does not live with biological parents, a copy of guardianship papers
- Child nutrition applications must be complete via the MCSD website- (NEW STUDENTS ONLY)
