

District Parental Involvement Policy

PART I. GENERAL EXPECTATIONS

Dover Public School agrees to implement the following statutory requirements:


PART III. DISCRETIONARY DISTRICTWIDE PARENTAL INVOLVEMENT POLICY COMPONENTS

- providing other reasonable support for parental involvement activities under Section 1118 as parents may request.


PART IV. ADOPTION
