REQUEST FOR PROPOSAL On-Call Nuisance Abatement Services

Project Overview

The City of Choctaw is interested in preserving the health, safety, and wellbeing that residents have come to expect. The purpose of this RFP is to solicit and identify qualified contractors who can provide on-call nuisance abatement services. Nuisance Abatement Services include, but are not limited to, mowing, weed, and vegetation abatement, site clean-up, trash and debris removal, boarding and securing structures.

Background

The City of Choctaw encompasses twenty-seven (27) square miles with a population of just under 13,000 residents. The city has a feeling that is rural in nature with a growing downtown commercial district. With just a thirty-minute drive to downtown Oklahoma City and an even shorter commute to Tinker Air Force Base, residents enjoy the rural nature of Choctaw with a short commute to the Midwest City and Oklahoma City.

Scope of Services

Scope of Services:

- On private lots, contractor will be required to perform abatement services, including but not limited to the following: mow, trim grass and vegetation (vegetation to include but not limited to the following: dead, overgrown, or hazardous trees, grass, weeds, and shrubs), remove hanging dry, dead, or decaying tree limbs and branches, removing piles of tree limbs;
- Contractor will be required to remove and dispose of ALL trash, junk and debris to include but not limited to the following: discarded wood, plastic, metal, furniture, exercise equipment, bicycles, vehicles, vehicle parts, appliances, electronics, construction debris or materials, waste oil, batteries, or similar materials;
- Contractor may be required to clear easements, right-of-ways and sight distance triangles (line of sight hazards);

Proposal Cost

The Contractor shall provide an itemized schedule of charges for labor and expenses that would generally be necessary to conduct services as defined in the section labeled 'Scope of Services'. Include the company's basic fee structure and breakdown of any other charges and hourly rates related to the proposal.

Desired Qualifications

Contractors for Nuisance Abatement Services shall meet the general requirements.

- Contractor shall have the ability to provide services within 24 hours of a request from the City.
- Contractor shall have trained and qualified staff to perform the requested work in a professional manner.
- Contractor shall furnish all vehicles and equipment necessary to complete the scope of work.
- Contractor shall have the equipment and ability to produce digital photographs, including a time and date stamp, of a job site before and after work is performed.
- Contractor must be able to provide proof of the minimum insurance requirements required by the City.
- Contractor shall be appropriately licensed, as necessary, with the state of Oklahoma, and must maintain such license(s) throughout the duration of the service contract with the City.
- The Contractor must comply with all applicable laws related to the transportation and disposal of waste.
