The motion to nominate Andrew Wynn as board treasurer was made by Steven Patterson; second by Amanda Walker. The motion passed 5-0-1 with Wynn abstaining.

The motion to appoint Sammi Parker as the MSBA delegate was made by Andrew Wynn; second by Phillip Mercer. The motion passed 5-0-1 with Parker abstaining.

The motion to appoint Phillip Mercer as the MSBA alternate delegate was made by Sami Parker; second by Amanda Walker. The motion passed 5-0-1 with Mercer abstaining.
