C. HEARING OF PRINCIPALS: Principal Grant's report included Eighth Grade Promotion update, summer maintenance and the number of students retained for summer school.

Principal Swanson discussed summer school maintenance and stated the current MEL should be in place for at least the next two years. Summer School started June 6 with two high school students working towards AR points and five middle school students working on math and/or reading.

ADMINISTRATIVE A. LONGITUDINAL STATE TESTING ANNUAL REPORT:

Shari Taylor, district Curriculum/Data Analysis Director presented the State Assessment Longitudinal Data as well as the previously presented 2011 KCA reports and addressed guestions. USD #378 student results were also compared to state results showing improvements for math and reading.

#### B. STRATEGIC PLAN AD HOC COMMITTEE REPORT:

Ad Hoc Committee members Jennifer Wilson, Steve Reed and **Superintendent Starnes provided Strategic Plan information** obtained from KASB, and bond election information previously discussed. The emphasis of a bond election would focus upon safety and security as provided by the Homeland Security report, Energy savings updates per our energy audits, providing ADA updates, previous strategic planning committee input and input from BOE & community meetings.
