- Item 2. Brenda Hilyard, Doug Boughner, Mrs. Frank Wallace, Jay Jenkins and Jon Humphrey were also present at the meeting.
- Item 3. The Invocation was presented by Clint Hallett.
- Item 4. The Pledge of Allegiance was presented by Third Graders, Leila Ewers, Caleb Parrish and Kaylee Bashford.
- Item 5. Frank Wallace made the motion to approve the audit by the firm of Jenkins & Kemper, CPA for Nowata Public Schools for 2016-2017. Charlotte Smalley seconded and motion carried (5-0) as follows: Holland-yes, Hallett, yes, Kester-yes, Wallace-yes and Smalley-yes. - Item 6. Charlotte Smalley made a motion to approve the following items on the consent agenda.

- (1) Middle School is also piloting Odysseyware.
- (2) Students of the month for December are: 8th grade Chris Tyron and Minnie Moore, 7th grade Jack Woolman and Stephanie Halsell, 6th grade Mesa Holt and Zack Pendergraft.
- Working on relationships in the middle school and one way is implementing IRONBUDDIES. We are simply asking each student who is the adult or adults in our building they feel comfortable going to when they need an adult. We then find out who didn't put anyone on the slip and they become our targets to engage more and try to find ways to develop a connection.
- (4) Basketball season just completed and our teams competed hard and represented our school district very well.
