- Item 1. The President called the meeting to order in the Commons Area and noted that all members were present except Clint Hallett, Vice President.
- Item 2. Angelia Franke, Jared Fields, First Church of God and Doug Boughner were also present at the meeting.
- Item 3. The Invocation was presented by Jared Fields, First Church of God.
- Item 4. The Pledge of Allegiance was presented by third grade students, Kason Summers, Daeton Stevens and Ruthie Fields.
- Item 5. Charlotte Smalley made a motion to approve the following items on the consent agenda.

- Our teachers are working so hard. This is evident when you look at our "ineligible list". Currently we have 50% fewer students failing classes.
