ORDINANCE NO. 2021-65 INTRODUCED BY: ADMINISTRATION

AN ORDINANCE AUTHORIZING CHANGE ORDER NO. 1 WITH EQUIX INTEGRITY, INC. FOR THE 2020 SEWER INSPECTION & CLEANING PROGRAM, AUTHORIZING THE CLOSEOUT OF SAID CONTRACT, AND DECLARING AN EMERGENCY

WHEREAS, the City has previously entered into a Contract with Equix, Inc., for the 2020 Sewer Inspection & Cleaning Program: and

WHEREAS, Equix Integrity, Inc. has successfully completed the Contract; and

WHEREAS, it is necessary to enter into a Change Order as set forth herein in order to initiate and complete the close out procedure. Now, therefore,

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LYNDHURST, CUYAHOGA COUNTY, STATE OF OHIO, THAT:

SECTION 1. The Mayor be and he is hereby authorized to enter into a Change Order Contract with Equix Integrity, Inc., for the credit amount of Seventy-Three Thousand Three Hundred Eleven Dollars and Ten Cents (\$73,311.10), in addition to the Contract heretofore authorized by the Board of Control of this Council, for final reconciliation of Contract quantities of said Contract, as more fully set forth in Change Order No. 1 dated August 30, 2021, which is fully incorporated herein, The City Engineer has approved the aforesaid Change Order.

<u>SECTION 2.</u> The Director of Finance be and is hereby authorized and directed to credit the amount provided for in Section 1 of this Ordinance upon passage hereof and execution of the Change Order authorized herein and completion of the work.

SECTION 3. This Council determines that the work included in the Contract with Equix Integrity, Inc. has been completed, and the contract may be closed out, and the retainage released, pursuant to the application and certificate for final payment, the final Contract price, including additions and deletions, being One Hundred Ninety-Six Thousand Three Hundred Eight Dollars and Ninety Cents (\$196,308.90). This final payment amount has been approved by the City Engineer.

SECTION 4. The Mayor be and is hereby authorized to execute all documents necessary to complete the closeout of this Contract in accordance with this Ordinance.

SECTION 5. The Council finds and determines that all formal actions of this Council relating to the adoption of this Ordinance have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

SECTION 6. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City of Lyndhurst and its residents for the reason that it is necessary to approve the aforesaid changes so as to not unnecessarily delay the completion of the aforesaid Project. Therefore, this Ordinance shall take effect immediately upon the affirmative vote of not less than five (5) members elected to Council, and signature by the Mayor, or otherwise at the earliest time allowed by law.
