

**RESOLUTION NO. 2019-2**  
**INTRODUCED BY: ADMINISTRATION**

**A RESOLUTION AUTHORIZING THE MAYOR TO  
IMPLEMENT HEALTH CARE COVERAGE FOR THE  
EMPLOYEES OF THE CITY AND DECLARING AN  
EMERGENCY**

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF LYNDBURST,  
COUNTY OF CUYAHOGA, STATE OF OHIO, THAT:**

**SECTION 1.** The Mayor is hereby authorized and directed to enter into necessary agreements to implement health care coverage for the eligible employees of the City with Anthem at the following monthly rates, effective January 1, 2019:

| Monthly Rates by Category | Anthem PPO 1000 Option<br>5 Rx T2 | Anthem HSA 2700 Option<br>E1 Rx T8 |
|---------------------------|-----------------------------------|------------------------------------|
| Employee Only             | \$ 480.34                         | \$ 412.11                          |
| Employee and Spouse       | \$ 1,412.10                       | \$ 1,211.52                        |
| Employee and Children     | \$ 841.10                         | \$ 721.62                          |
| Family                    | \$ 1,475.48                       | \$ 1,265.89                        |

**SECTION 2.** The rates specified above for health care are for a twelve-month period beginning January 1, 2019. Should it become necessary to extend this coverage beyond the aforesaid twelve-month period, Council shall approve any extension and any increase in the stated rates, if applicable.

**SECTION 3.** All actions taken by the Mayor and the Director of Finance to provide health care coverage to City employees prior to the adoption of this Resolution, and pursuant to Resolution No. 2018-95 adopted December 3, 2018, are hereby ratified and approved.

**SECTION 4.** Council finds and determines that all formal actions of this Council relating to the adoption of this Resolution have been taken at open meetings of this Council; and that deliberations of this Council and of its committees, resulting in such formal action, took place in meetings open to the public, in compliance with all statutory requirements including the requirements of Section 121.22 of the Ohio Revised Code.

**SECTION 5.** This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the health, safety and welfare of the residents of the City for the reason that it is necessary to implement the aforesaid insurance coverage for the employees of the City so that the same are effective as of January 1, 2019. Therefore this Resolution shall take effect immediately upon the affirmative vote of not less than five members elected to Council and signature by the Mayor or otherwise at the earliest time allowed by law.
