REGULAR MEETING<br>BOARD OF EDUCATION

February 19, 2019

## 1. CALL TO ORDER:

The Board of Education of Community Unit School District \#3, Fulton County, met in regular session on February 19, 2019, in the Cuba Elementary Library, 652 East Main Street, Cuba. President Sue McCance called the meeting to order at 6:30 P.M.
2. ROLL CALL:

Roll call was taken with the following members present: Mr. Corsaw, Mrs. Davis, Mrs. Deakin, Mrs. McCance, Mr. Wallace and Mrs. Wilson.

President McCance led the Board in the Pledge of Allegiance.

Mrs. Sara Gilpin spoke to the Board on behalf of the After-Prom Committee about use of buses to transport students to After-Prom. She also announced the last fundraiser for After-Prom will be a chicken noodle dinner at the Red Brick School March 2 from 11:00 a.m. - 2:00 p.m.
5. COMMUNICATIONS:

Under communications, Mrs. Simmons-Kenser shared attendance reports from both buildings.
6. APPROVAL OF AGENDA:

MOTION by Mrs. Wilson, seconded by Mrs. Davis to approve the agenda as amended. 8. PRINCIPALS' REPORTS:

Under Principals' reports, Mr. Braun announced Madison Easley as the Senior of the Month for February. The District Spelling Bee was held on

February 1. The winner was Kacie White, 4th grade; runner-up was Washita Bradford, 7th grade; and alternate was Elayna Sanderson, 4th grade. The Regional Spelling Bee will be held February 20 at 1:00 p.m. in the Lewistown High School Auditorium. On January 20, the Middle School cheer squad competed in an ICCA (Illinois Cheerleading Coaches Association) competition at Knoxville High School. The teams ranged from small junior high to high school co-ed. The girls did a great job! Students and staff completed the 5 Essentials survey the week of February 11. The survey was made available to parents via the website and district app. https://survey.5-essentials.org/illinois/. FCCLA was a recipient of $\$ 555.00$ from Canton's Helping Hands for the week of January 13-19. The money will be used to help pay for the members' registration for Section Rally on February 25. Mrs. Brewer's classroom was the recipient of HOI's One Class at a Time grant for February 20. She received $\$ 1,000$ in classroom funds. The story was to air Wednesday, February 20.

Mrs. Simmons-Kenser announced both the January and February Buzzy Bee winners will be announced in February. Cuba Elementary was well represented in the District Spelling Bee. First place winner was Kacie White from Mrs. Russell's fourth grade class. She will be competing in the County Spelling Bee on February 20. Jump Rope for Heart was held on February 8. Cuba Elementary raised over $\$ 2,554$ with the two top individual fundraisers being Grace Yaste and Trenton Ford. They were treated to lunch with Mr. Shaeffer. A few staff members from Cuba Elementary, the Middle School and Mrs. Simmons-Kenser attended the state ESSA conference in Chicago the week of February 11. New legislation will bring about more changes in District grants, funding allocations to districts and how these allocations can be spent. This was an excellent conference showcasing some terrific things happening around the state.

There was a question and discussion about bus routes during snow events. The important thing is that students' safety was the main consideration and priority as it will continue to be. Delayed starts were mentioned as an alternative. The main reason for not implementing delayed starts is that parents are not prepared. This option is being looked at and plans will be made to utilize delayed starts in the future. The Board showed support of the way decisions have been made based on student safety as the main concern.
